4. Successfully passing a written examination with a grade of at least 70.

This driver training school will not refund any tuition or part of tuition if the School is ready, willing, and able to fulfill its part of this contract. I understand that if I fail to comply with the terms and conditions of this agreement, I am in breach of contract and the school will not be under any obligation to fulfill the terms of this contract, and may, at its option, terminate this agreement immediately.

It is agreed that an owner, instructor, or employee of this driver training school shall not give the impression directly or implied to a student that upon completion of this course the student will receive a license to operate a motor vehicle. However, immediately upon the student's successful completion of the course as described above, the driver training school agrees to provide certification of said completion to the student.

The driver training school has and will maintain the protection of the contractual rights of the student a performance bond in the principal sum of ten thousand (\$10,000.00) dollars for the students to be written by a company authorized to do business in the State of Georgia.
